# Pr-qualifying terms and conditions for submitting bids for tender for provision of Security Guards for the office of the High Commission of India.

- 1. All bidders should submit along with the Tender the following documents:
- (i) Separate bids in the sealed envelopes in the prescribed Technical and Financial Bid Document (proformas attached in Chapter II and III)
- (ii) Both the above documents must be signed by authorized signatories of the bidding firm with a seal/stamp
- (iii) Self attested photo-copy of registration of the company/firm/proprietorship with the concerned Ghanaian authorities.
- (iv) Annual Report ( where statutorily required to be filed) and financial Reports for the last 3 years
- (v) Details of experience in the field of security services with Embassies/reputed companies/Government agencies etc.
- (vi) Subject to above condition, the company should have sufficient security guards on its roll so that the staff is rotated periodically.
- 2. **Age**: Age of Security Guards should not be more than 50 years.
- 3. **Physical and Mental Fitness**: Security guards should be physically and mentally fit. He/she should not suffer from an apparent disability including obesity/overweight that would hinder efficient discharge of his/her duties
- 4. **Verification of Character and antecedents**: The security guard should have been vetted by the Gabonese Ministries/Police authorities in terms of past record, character and antecedents. The service provider should be able to provide background details of the guards and also proof of their vetting.
- 5. **Uniform & appearance**: The guards should perform their duties in smart uniforms and their overall appearance should be neat and clean.
- 6. **Training**: Guards should posses training in basic security duties such as access control and anti-sabotage checks (of person, baggage and vehicles) including the use of basic security tools such as HHMD, DFMD, monitoring CCTV, baggage and letter scanners etc. They should possess knowledge of the potential threats to a foreign diplomatic mission in general terms and a knowledge of what is suspicious in terms of men and material.
- 7. **Supervision**: Service provider should have provision of real time checks of functioning of the security guards to ensure that the quality of the provided staff and the service they render is always above the benchmark. The security firm should be able to provide proof of this to the Mission.
- 8. **Knowledge of Language**: Besides the local/native language, guards should have working knowledge of English so that there is no communication gap
- 9. **Service conditions of the guards**: The service provider should agree to provide details of salary, gratuity, allowances, leave rules etc. that it provides to his guards.
- 10. **Option to chose & retain**: The service provider should be able to provide a choice of guards and in case of 'good performance' by particular guard(s), the High Commission of India should have the option of retaining a particular guard(s).
- 11. The security guard on duty will be responsible for switching on (in the evening) and switching off (in the morning) the security lights and sensors of the premises.
